


# Secretary-General's Mechanism for Investigation of Alleged Use of Chemical and Biological Weapons (UNSGM)

Third Session of the Working Group on the Strengthening of the BWC Palais des Nations, Geneva 6 December 2023





MEASURES TO UPHOLD THE AUTHORITY OF THE 1925 GENEVA PROTOCOL AND TO SUPPORT THE CONCLUSION OF A CHEMICAL WEAPONS CONVENTION

#### The General Assembly,

*Recalling* the provisions of the Protocol for the Prohibition of the Use in War of Asphyxiating, Poisonous or Other Gases, and of Bacteriological Methods of Warfare, signed at Geneva on 17 June 1925,<sup>39</sup> and other relevant rules of customary international law,

### **UNSGM Mandate**

Mandate given by General Assembly resolution A/42/37 C: "Measures to uphold the authority of the 1925 Geneva Protocol and to support the conclusion of a chemical weapons convention"

 O.P. 4 Requests the Secretary-General to carry out investigations in response to reports that may be brought to his attention by any Member State concerning the possible use of chemical, bacteriological (biological) or toxin weapons that may constitute a violation of the Geneva Protocol or other relevant rules of customary international law in order to ascertain the facts of the matter and to report promptly the results of any such investigation to all Member States.



Mandate was reaffirmed by Security Council resolution 620 (1988)

### **UNODA's Role**



UNODA serves as the custodian of the UNSGM. This role includes:

- Ensuring the operational readiness to carry out a mission in response to reports from Member States
- Maintaining the roster of nominated experts and laboratories
- Coordinating on training activities with partners, including Member States, laboratories and international organizations
- Conducting outreach activities
- Coordinating the UN Internal Task Force (UNITF) of points of contact within UN departments and agencies that would support a UNSGM mission and training





## The UNSGM is:

- A tool at the disposal of the UN Secretary-General in response to report(s) from Member States
- An impartial, science-based, international mechanism for investigation of alleged use of chemical and biological weapons
- The only international mechanism to investigate the alleged use of biological weapons

- NOT a standing investigative body
- NOT a capacity building mechanism
- NOT an early response, containment or preventative mechanism
- NOT linked to the Biological Weapons
   Convention



## **UNSGM Guidelines & Procedures**

(A/44/561)

- Cover the preparation and conduct of a UNSGM investigation, e.g., technical procedures or report writing
- Detail the roles of:
  - UN Secretary-General
  - Member States
  - State(s) receiving investigation
  - International organizations
  - Qualified experts
  - Expert consultants
  - Analytical laboratories

	Qualified Experts	May be called upon to actively <b>participate in an investigation</b> team to conduct investigations into the alleged use of CBT weapons. May be called upon for training.
	Expert Consultants	May be requested to <b>advise and</b> <b>assist</b> in the overall conduct and operation of the UNSGM, from planning, deployment to operation and reporting.
	Analytical Laboratories	May be requested to <b>test for the</b> <b>presence of CBT agents</b> . May be called upon for interlaboratory calibration studies.



## **Nomination process**

- Only Member States can nominate experts and analytical laboratories to the roster and do so by official communication (Note Verbale)
- UNODA sends a Note Verbale to all UN Member States each year to request nominations for the UNSGM roster (next: December 2023)
- Member States can submit new nominations or update their nominations anytime
- UNODA maintains the roster (confidential)
- Once nominated, UNODA requests standard forms for qualified experts and laboratories to collect more information
- To test responses and make sure the roster is up-to-date, UNODA conducts annual callout exercises (last: November 2023)

### Training Programme Objectives

The operating environment for a UNSGM mission is likely to be:

- Time-sensitive
- Multi-faceted (various expertise needed)
- A diverse team whose members are not familiar with each other
- Politically complex
- Potentially hazardous

#### Member States nominate experts, why train?

- To ensure the operability of the UNSGM, especially the timely, efficient and accurate conduct of a UNSGM investigation into the reports of use of CBT weapons
- Convey additional capabilities and skills, e.g., (joint) interviews, establishing and maintaining chain-of custody
- Report writing and the difference from scientific papers
- Team-building



### Training Programme Phases

- A three-phased training approach for **experts** was implemented to:
- Create a more systematic approach
- Broaden the base of trained experts
- Increase engagement by Member States that provide trainings

#### Phase One: Basic training course

 All nominated experts should participate in a two-week basic training to understand the mandate, roles and responsibilities

#### Phase Two: Core Skills Training

• Specialized skills training in various areas (~1 week)

#### **Phase Three: Capstone**

 Advance scenario that fuses skills training and professional experience into a table-top or field exercise
