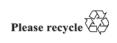

Estimated Costs 2026 Twenty-eighth Annual Conference of the High Contracting Parties to Amended Protocol II*

- 1. The Twenty-seventh Annual Conference of the High Contracting Parties to Amended Protocol II to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons which May Be Deemed to Be Excessively Injurious or to have Indiscriminate Effects, to be held in Geneva on 11 November 2025, is to decide to convene the Twenty-eighth Annual Conference in 2026.
- 2. This document is submitted to assist the decision of the High Contracting Parties. The Sixth Review Conference, held in Geneva on 13-17 December 2021, adopted a budget for 2026 as contained in CCW/CONF.VI/10 (CCW/CONF.VI/11, paragraph 32), including the cost estimates of the Conferences of High Contracting Parties to Amended Protocol II. In accordance with this decision, the estimated costs of US\$ 88,400 for the one-day Twenty-eighth Conference are identical to the cost estimates of the Twenty-seventh Conference (CCW/AP.II/CONF.26/4) adopted by the Twenty-sixth Conference of the High Contracting Parties to Amended Protocol II held in November 2024, plus the 5% contingency. A breakdown of these costs is provided in the attached table.
