

**Twenty-seventh Annual Conference of the High Contracting Parties to Amended Protocol II to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects**

**Final document \***

**I. Introduction**

1. Article 13 of the Protocol on Prohibitions or Restrictions on the Use of Mines, Booby-Traps and Other Devices, as amended on 3 May 1996 (Amended Protocol II), annexed to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects (CCW), provides for a conference of the High Contracting Parties to the Protocol to be held annually for the purpose of consultations and cooperation on all issues related to the operation of the Protocol.
2. The Twenty-sixth Annual Conference, held on 12 November 2024, decided to recommend to the Twenty-seventh Annual Conference a provisional agenda, as contained in its final document (CCW/AP.II/CONF.26/5, annex II). It also adopted the estimated costs of the Twenty-seventh Annual Conference (CCW/AP.II/CONF.26/4).
3. The Twentieth Annual Conference, in paragraph 31 of its final document (CCW/AP.II/CONF.20/5) decided that each future President-designate may select one or several of the articles of Amended Protocol II which would then, upon the approval by High Contracting Parties, be addressed during the Annual Conference under his/her authority without prejudice to a comprehensive and balanced discussion on the Amended Protocol II and the Convention.
4. The Twenty-sixth Annual Conference decided, in paragraph 20 of its final document (CCW/AP.II/CONF.26/5), that the Group of Experts will review the operation and status of the Protocol, including matters arising from reports by High Contracting Parties according to Article 13 (4) of Amended Protocol II, under the overall responsibility of the President-designate; and the issue of improvised explosive devices (IED), under the overall responsibility of the IED Coordinators. The Conference also decided that the work of the Group of Experts will be considered by the Twenty-seventh Annual Conference.
5. The Twenty-sixth Annual Conference decided to nominate Ambassador Carlos Foradori of Argentina as President-designate of the Twenty-seventh Annual Conference, as indicated in paragraph 22 of its final document (CCW/AP.II/CONF.26/5).
6. The 2024 Meeting of the High Contracting Parties to the Convention decided in its final report (CCW/MSP/2024/7, paragraph 28 (e)) that the Twenty-seventh Annual Conference of the High Contracting Parties to Amended Protocol II would be held on 11 November 2025 in Geneva.
7. The Twenty-seventh Annual Conference of the High Contracting Parties to Amended Protocol II was prepared for by a Group of Experts, which took place for two days from 9 to

10 September 2025 in Geneva, as decided by the 2024 Meeting of the High Contracting Parties to the Convention in its final report (CCW/MSP/2024/7, paragraph 28 (b)).

## **II. Organization of the Twenty-seventh Annual Conference**

8. The Twenty-seventh Annual Conference of the High Contracting Parties to Amended Protocol II was convened on 11 November 2025 at the Palais des Nations in Geneva.

9. The following High Contracting Parties to Amended Protocol II participated in the work of the Conference: Albania, Argentina, Australia, Austria, Bangladesh, Belarus, Belgium, Brazil, Bulgaria, Burkina Faso, Cameroon, Canada, China, Colombia, Croatia, Czech Republic, Cyprus, Denmark, Dominican Republic, Ecuador, Estonia, Finland, France, Georgia, Germany, Greece, Holy See, Hungary, India, Iraq, Ireland, Israel, Italy, Japan, Jordan, Latvia, Lithuania, Montenegro, Morocco, Netherlands (Kingdom of the), Nicaragua, North Macedonia, Norway, Pakistan, Panama, Peru, Philippines, Poland, Portugal, Republic of Korea, Russian Federation, Serbia, Slovakia, Slovenia, South Africa, Spain, Sri Lanka, Sweden, Switzerland, Tunisia, Türkiye, Ukraine, United Kingdom of Great Britain and Northern Ireland, and United States of America and Venezuela (Bolivarian Republic of).

10. The following High Contracting Parties to the Convention participated as observers: Côte d'Ivoire, Cuba, Lao People's Democratic Republic, Saudi Arabia, State of Palestine, and Uganda.

11. The following States not party to the Convention participated as observers: Azerbaijan and Thailand.

12. The representatives of the United Nations Mine Action Service (UNMAS) also participated in the work of the Conference as observers.

13. The representatives of the following organizations also took part in the work of the Conference as observers: European Union, Geneva International Centre for Humanitarian Demining (GICHD) and International Committee of the Red Cross (ICRC).

14. The representatives of the following non-governmental organizations and other entities also took part in the work of the Conference as observers: Article 36 and DMUN Foundation.

## **III. Work of the Twenty-seventh Annual Conference**

15. The Twenty-seventh Annual Conference of the High Contracting Parties to Amended Protocol II was opened on 11 November 2025 by Ms. Tsholofelo Tsheole of South Africa as President of the Twenty-sixth Annual Conference, who presided over the confirmation of the nomination of Ambassador Carlos Mario Foradori of Argentina as President of the Twenty-seventh Annual Conference.

16. The Conference held one plenary meeting. At this plenary meeting, the Conference also confirmed the nominations of Ambassador Shen Jian of China and Ms. Mateja Kavaš of Slovenia as Vice-Presidents.

17. The High Contracting Parties did not consider the adoption of the agenda, as contained in CCW/AP.II/CONF.27/1, nor the confirmation of the Rules of Procedure, as contained in CCW/AP.II/CONF.15/7 and its corrigendum (CCW/AP.II/CONF.15/7/Corr.1), as there was no consensus on these issues.

18. The CCW Implementation Support Unit provided administrative support to and prepared documentation for the Conference.

19. During the course of the meeting, the Conference considered documents CCW/AP.II/CONF.27/1 to CCW/AP.II/CONF.27/4. The documents of the Conference are available in all official languages on the CCW website (<https://meetings.unoda.org/node/74778>), as well as through the United Nations Official Document System (ODS), at <http://documents.un.org>.

20. In accordance with Article 13, paragraph 4 of the Protocol, the Conference had before it national annual reports from the following High Contracting Parties: Albania, Argentina, Australia, Austria, Belarus, Belgium, Bolivia, Bosnia and Herzegovina, Brazil, Bulgaria, Cabo Verde, Cambodia, Canada, Chile, China, Colombia, Croatia, Czech Republic, Denmark, Ecuador, El Salvador, Estonia, Finland, France, Georgia, Germany, Greece, Holy See, Honduras, Hungary, Iceland, India, Iraq, Ireland, Israel, Italy, Japan, Jordan, Latvia, Liechtenstein, Lithuania, Luxembourg, Maldives, Mauritius, Monaco, Montenegro, Netherlands (Kingdom of the), New Zealand, Nicaragua, Norway, Pakistan, Peru, Poland, Portugal, Republic of Korea, Republic of Moldova, Russian Federation, Serbia, Slovakia, Spain, Sweden, Switzerland, Tunisia, Türkiye, Ukraine, United Kingdom of Great Britain and Northern Ireland, United States of America, and Uruguay.

The reports contained information on:

- (a) Dissemination of information on the Protocol to armed forces and to the civilian population;
- (b) Mine clearance and rehabilitation programmes;
- (c) Steps taken to meet technical requirements of the Protocol and any other relevant information pertaining thereto;
- (d) Legislation related to the Protocol;
- (e) Measures taken on international technical information exchange, on international cooperation on mine clearance, and on technical cooperation and assistance;
- (f) Other relevant matters; and
- (g) Information provided to the database on mine clearance established within the United Nations System.

A synopsis of national annual reports submitted for the Twenty-seventh Annual Conference is contained in annex III of this report.

#### **IV. Follow-up**

21. The Conference decided that the 2026 session of the Group of Experts will be for a duration of two days and the dates are to be decided by the Meeting of High Contracting Parties to the Convention, to be held on 12 November 2025. The Conference also adopted the estimated costs of the 2026 Group of Experts, as contained in CCW/AP.II/CONF.27/3.

22. The Conference decided that the Group of Experts will review the operation and status of the Protocol, including matters arising from reports by High Contracting Parties according to Article 13 (4) of Amended Protocol II, under the overall responsibility of the President-designate; and the issues on IED, under the overall responsibility of the IED Coordinators. The work of the Group of Experts will be considered by the Twenty-eighth Annual Conference.

23. The Conference decided that the Twenty-eighth Annual Conference will be convened in 2026 on the dates to be decided by the Meeting of High Contracting Parties to the Convention, to be held on 12 November 2025. The Conference decided to recommend to the Twenty-eighth Annual Conference a provisional agenda, as contained in annex II. It also adopted the estimated costs of the Twenty-eighth Annual Conference, as contained in CCW/AP.II/CONF.27/4.

24. The Conference decided to nominate a representative of the Eastern European Group (EEG) as President-designate of the Twenty-eighth Annual Conference of the High Contracting Parties to Amended Protocol II to be held in 2026, and representatives of China, the Group of Non-Aligned Movement (NAM) and the Western European and Others Group (WEOG) as Vice-Presidents-designates.

25. At its plenary meeting, the Twenty-seventh Annual Conference adopted its final document as contained in CCW/AP.II/CONF.27/CRP.3, as orally amended, which will be issued as document CCW/AP.II/CONF.27/5.

## **Annex I**

### **An appeal by the Twenty-seventh Annual Conference of the High Contracting Parties to Amended Protocol II on universalization**

**(as adopted on 11 November 2025)**

*We, the High Contracting Parties which have notified the Depositary of our consent to be bound by Amended Protocol II to the CCW, meeting in Geneva on 11 November 2025 for our Twenty-seventh Annual Conference:*

*Bearing in mind* the important contribution of Amended Protocol II to international efforts to alleviate the suffering caused by certain conventional weapons which may be deemed to be excessively injurious or to have indiscriminate effects,

*Noting* that Amended Protocol II is the only international legal instrument which covers all types of mines, booby-traps and other devices,

*Having reviewed* the operation and status of Amended Protocol II, in accordance with paragraph 3 (a) of Article 13,

*Having considered* the national annual reports presented by High Contracting Parties which have notified the Depositary of their consent to be bound by Amended Protocol II,

1. *Welcome* the fact that 107 High Contracting Parties have notified the Depositary of their consent to be bound by Amended Protocol II;
2. *Emphasize* the importance of achieving universalization of Amended Protocol II, including widest possible adherence to it;
3. *Urge* all States that have not yet done so to take all measures to accede to Amended Protocol II as soon as possible.
