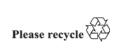

Consideration and adoption of the final document

#### **Final document**

#### I. Introduction

- 1. Article 10 (1) and (2) of Protocol V on Explosive Remnants of War states the following:
  - "1. The High Contracting Parties undertake to consult and co-operate with each other on all issues related to the operation of this Protocol. For this purpose, a Conference of High Contracting Parties shall be held as agreed to by a majority, but no less than eighteen High Contracting Parties.
    - 2. The work of the conferences of High Contracting Parties shall include:
    - (a) Review of the status and operation of this Protocol;
  - (b) Consideration of matters pertaining to national implementation of this Protocol, including national reporting or updating on an annual basis;
    - (c) Preparation for review conferences."
- 2. The First Conference of the High Contracting Parties decided, as stipulated in paragraph 38 of its final document (CCW/P.V/CONF/2007/1), to establish a mechanism for consultation and cooperation under Protocol V, consisting of informal meetings of experts, chaired by Coordinators, on issues relevant to the implementation of the Protocol.
- 3. The First Conference also decided, as stipulated in paragraph 42 of its final document (CCW/P.V/CONF/2007/1), that the work of the Meetings of Experts shall be considered by the Conferences of the High Contracting Parties to be held annually.
- 4. The Sixth Review Conference of the High Contracting Parties to the Convention, CCW/CONF.VI/11, encouraged the High Contracting Parties to Protocol V, to "continue with their efforts to encourage a higher rate of national reporting, including through consideration at the Meeting of Experts; to consider in-depth the clearance of explosive remnants of war and generic preventive measures; and to prioritize the work on cooperation and assistance and victim assistance".
- 5. The High Contracting Parties to Protocol V designated, through a written silence procedure, Ambassador Gordan Markotić of Croatia, as President-designate of the Seventeenth Conference.
- 6. Informal open consultations, on an exceptional basis and without setting a precedent for the future, took place on 8 November 2023 in Geneva, as decided by the 2022 Meeting of the High Contracting Parties to the Convention in its final report (CCW/MSP/2022/7, paragraph 36).





#### II. Participation in the Seventeenth Conference

- 7. The Seventeenth Conference of the High Contracting Parties to Protocol V on Explosive Remnants of War was convened on 13 November 2023 at the Palais des Nations in Geneva.
- 8. The following High Contracting Parties to Protocol V participated in the work of the Conference: Albania, Argentina, Australia, Austria, Belarus, Belgium, Bosnia and Herzegovina, Brazil, Bulgaria, Canada, Chile, China, Costa Rica, Cote d'Ivoire, Croatia, Cuba, Czech Republic, Denmark, Dominican Republic, Ecuador, El Salvador, Estonia, Finland, France, Georgia, Germany, Guatemala, Holy See, Hungary, India, Iraq, Ireland, Italy, Kuwait, Lao PDR, Latvia, Lithuania, Montenegro, Netherlands (Kingdom of the), Norway, Pakistan, Panama, Peru, Philippines, Poland, Portugal, Qatar, Republic of Korea, Romania, Russian Federation, Saudi Arabia, Slovakia, Slovenia, South Africa, Spain, State of Palestine, Sweden, Switzerland, Tunisia, Ukraine, United Arab Emirates, United States of America and Uruguay.
- 9. The following High Contracting Parties to the Convention participated in the work of the Conference as observers: Israel, Japan, Kazakhstan, Morocco, Serbia, Sri Lanka, Togo, Türkiye and United Kingdom of Great Britain and Northern Ireland.
- 10. The following observer delegation participated in the work of the Meeting: Singapore.
- 11. The representatives of the following organizations took part in the work of the Conference as observers: European Union, Geneva International Centre for Humanitarian Demining (GICHD), International Committee of the Red Cross (ICRC) and the United Nations Mine Action Service (UNMAS).
- 12. The representatives of the following non-governmental organizations and other entities also took part in the work of the Conference as observers: Human Rights Watch, Maat for Peace, Development and Human Rights, and Network of the Independent Commission for Human Rights in Northern Africa.

#### III. Work of the Seventeenth Conference

- 13. The Seventeenth Conference of the High Contracting Parties to Protocol V on Explosive Remnants of War was opened on 13 November 2023 by Ambassador Ignacio Sánchez Lerín García-Ovies of Spain, as the President of the Sixteenth Conference, who presided over the election of Ambassador Gordan Markotić of Croatia as President of the Seventeenth Conference.
- 14. The Conference held two plenary meetings. At its first plenary meeting, the Conference also elected Ambassador Abdul-Karim Hashim Mostafa of Iraq and Ambassador Ignacio Sánchez Lerín García-Ovies of Spain as Vice-Presidents of the Conference.
- 15. At the same plenary meeting, the Conference adopted its agenda, as contained in CCW/P.V/CONF/2023/1. In confirming its Rules of Procedure, as contained in CCW/P.V/CONF/2013/10, the Conference decided to suspend Rule 2, in accordance with paragraph 42 of the final document of the Seventh Conference. Without setting any precedent for future meetings of the Annual Conference of Protocol V, the Rules of Procedure of the Conference were confirmed by the Conference under the understanding that all observers at the Conference had the same status among them and could speak under agenda items 8 "General exchange of views" and 9 "Review of the status and operation of the Protocol" only after the statements of the High Contracting Parties.
- 16. The Conference confirmed the nomination of Ms. C. Mélanie Régimbal, Chief of Service of the Geneva Branch of the United Nations Office for Disarmament Affairs (UNODA), as Secretary-General of the Conference. Ms. Tania Bañuelos Mejía, Political Affairs Officer, UNODA Geneva Branch, served as the Secretary of the Conference. Ms. Juliana Helou-van der Berg, Political Affairs Officer, UNODA Geneva Branch, and Ms. Sophie Guillermin-Golet, Associate Political Affairs Officer, UNODA Geneva Branch, served in the Secretariat of the Conference.

- 17. During the course of the meeting, the Conference considered documents CCW/P.V/CONF/2023/1 to CCW/P.V/CONF/2023/4. The documents of the Conference will be made available in all official languages on the Convention on Certain Conventional Weapons (CCW) website (https://meetings.unoda.org/node/67238/), as well as through the United Nations Official Document System (ODS), at http://documents.un.org.
- 18. The following delegations participated in the general exchange of views: Argentina, Australia, Austria, Brazil, Canada, China, Cuba, France, Germany, India, Iraq, Ireland, Italy, Lao People's Democratic Republic, Netherlands (Kingdom of the), Pakistan, Peru, Republic of Korea, Russian Federation, Saudi Arabia, State of Palestine, Switzerland, Tunisia, Ukraine, United States of America, European Union, ICRC, Maat for Peace, Development and Human Rights, UNMAS.
- 19. The Conference took note of a report by the President on efforts undertaken to promote the universalization of Protocol V submitted by the President as document CCW/P.V/CONF/2023/WP.1 that includes the information on the efforts he undertook as President-designate regarding universalization, including meeting with 14 High Contracting Parties to the Convention who are not parties to Protocol V.
- 20. The Conference considered a report on the informal open consultations on Protocol V, submitted by the President-designate of the Seventeenth Annual Conference (CCW/P.V/CONF/2023/2) under his own responsibility upon the request by the 2022 Meeting of the High Contracting Parties to the Convention on an exceptional basis and without setting a precedent for the future. The report, which has not been agreed upon and has no official status, reflects the discussions held on clearance of explosive remnants of war and technical assistance and on victim assistance.
- 21. Pursuant to the decision of the First Conference to establish a database on Protocol V, in accordance with Article 10 (2) (b) of Protocol V, consisting of the national reports, annual or immediate updates of the national reports, and/or summary cover pages, if applicable, on matters pertaining to the implementation of Protocol V, as stipulated in paragraphs 24 to 28 of the final document of the First Conference, the Conference had before it national annual reports from the following High Contracting Parties: Argentina, Australia, Austria, Belarus, Belgium, Bosnia and Herzegovina, Brazil, Bulgaria, Canada, China, Croatia, Cuba, Cyprus, Czech Republic, Denmark, Dominican Republic, Ecuador, Estonia, Finland, France, Georgia, Germany, Holy See, Hungary, India, Iraq, Ireland, Italy, Lao People's Democratic Republic, Latvia, Liechtenstein, Lithuania, Mauritius, Montenegro, Netherlands (Kingdom of the), New Zealand, Nicaragua, Pakistan, Poland, Portugal, Qatar, Republic of Korea, Republic of Moldova, Romania, Russian Federation, Slovakia, Sweden, Switzerland, Tajikistan, Tunisia and United States of America.

#### IV. Conclusions and recommendations

#### A. Universalization

- 22. The Conference welcomed the efforts undertaken by the Secretary-General of the United Nations, the President of the Seventeenth Conference, the CCW Implementation Support Unit, organizations and the CCW Sponsorship Programme to promote the universalization of Protocol V.
- 23. The Conference recommended that the Secretary-General of the United Nations and the President-designate of the Eighteenth Conference, on behalf of the High Contracting Parties, exercise their authority to achieve the goal of universality of Protocol V.
- 24. The Conference called on all States that have not yet done so to consider consenting to be bound by Protocol V. The Conference also called on the High Contracting Parties to Protocol V and the Implementation Support Unit to promote wider adherence to Protocol V.

# B. Article 4 of the Protocol on "Recording, retaining and transmission of information"

25. The Conference decided that under the overall responsibility of the President-designate, High Contracting Parties should, on a voluntary basis and subject to national policies on the protection of sensitive information, continue to share national best practices on the implementation of Article 4 and generic preventive measures following also the guidance provided in the Technical Annex of the Protocol.

#### C. National reporting

- 26. The Conference took note of the report by the President on national reporting.
- 27. The Conference decided that, under the overall responsibility of the President-designate, High Contracting Parties are to continue with their efforts to encourage a higher rate of national reporting, including but not limited to the implementation of the measures adopted at the Eleventh Annual Conference (CCW/P.V/CONF/2017/5, paragraph 27). High Contracting Parties are also encouraged to consider measures to improve reporting methodology.

#### D. Victim assistance

28. The Conference also took note of the work undertaken by the Coordinator on Victim Assistance.

#### 29. The Conference decided:

- (a) To encourage all High Contracting Parties to promote the work of Protocol V on victim assistance and in particular the Plan of Action on Victim Assistance;
- (b) To encourage High Contracting Parties affected by explosive remnants of war to implement Article 8(2) of the Protocol and the Plan of Action on Victim Assistance, and to report on these actions in Form E(a) of the national annual report;
- (c) The Meeting of Experts should give particular focus to the exchange of information and experiences on implementation of the commitments on victim assistance at the national and community levels; to updates on the latest approaches and innovations in the field of victim assistance; and to exchanges of practical experiences and lessons learned with other relevant legal instruments and fora;
- (d) To request the Coordinator on Victim Assistance to prepare and chair relevant work of the 2024 Meeting of Experts and to report back to the Eighteenth Conference.

#### E. Clearance of explosive remnants of war

- 30. The Conference also took note of the work undertaken by the Coordinator on clearance and technical assistance.
- 31. The Conference decided that the Meeting of Experts should, under the overall responsibility of the Coordinator on Clearance and Technical Assistance, exchange information on a voluntary basis on methods of clearance of explosives remnants of war. The Conference also decided to request the Coordinator on Clearance and Technical Assistance to prepare and chair relevant work of the 2024 Meeting of Experts and to report back to the Eighteenth Conference.

#### F. Follow-up

32. The Conference decided that the 2024 Meeting of Experts will be for a duration of one day at a date to be decided by the 2023 Meeting of High Contracting Parties to the Convention, to be held from 15 to 17 November 2023.

- 33. The Conference decided that the Meeting of Experts should especially focus on the following issues, at the discretion of the President-designate of the Eighteenth Conference:
- (a) The issue of the universalization of Protocol V under the overall responsibility of the President-designate of the Eighteenth Conference;
- (b) Article 4 of the Protocol under the overall responsibility of the President- designate of the Eighteen Conference;
- (c) National reporting under the overall responsibility of the President-designate of the Eighteenth Conference;
- (d) Victim assistance under the overall responsibility of the Coordinator on Victim Assistance;
- (e) Clearance of explosive remnants of war under the overall responsibility of the Coordinator on Clearance and Technical Assistance.
- 34. The Seventeenth Conference encouraged High Contracting Parties in a position to do so to provide technical assistance to the High Contracting Parties in need of support.
- 35. The Conference decided to nominate a Representative of the NAM Group as President-designate of the Eighteenth Conference, and a representative of the WEOG and a representative of the EEG as Vice-Presidents-designates.
- 36. The Conference considered and approved a provisional agenda of the Eighteenth Conference, as contained in Annex I.
- 37. The Conference adopted the estimated costs of the 2024 Meeting of Experts and Eighteenth Conference, contained in CCW/P.V/CONF/2023/3 and CCW/P.V/CONF/2023/4 respectively.
- 38. At its second plenary meeting, the Seventeenth Conference of the High Contracting Parties to Protocol V on Explosive Remnants of War adopted its final document as contained in CCW/P.V/CONF/2023/CRP.1, as orally amended, which will be issued as document CCW/P.V/CONF/2023/5.
