Final document *

I. Introduction

1. Article 10 (1) and (2) of Protocol V on Explosive Remnants of War (ERW) states the following:

"1. The High Contracting Parties undertake to consult and co-operate with each other on all issues related to the operation of this Protocol. For this purpose, a Conference of High Contracting Parties shall be held as agreed to by a majority, but no less than eighteen High Contracting Parties.

2. The work of the conferences of High Contracting Parties shall include:

- (a) Review of the status and operation of this Protocol;
- (b) Consideration of matters pertaining to national implementation of this Protocol, including national reporting or updating on an annual basis;
- (c) Preparation for review conferences."

2. The First Conference of the High Contracting Parties decided, as stipulated in paragraph 38 of its final document (CCW/P.V/CONF/2007/1), to establish a mechanism for consultation and cooperation under Protocol V, consisting of informal meetings of experts, chaired by Coordinators, on issues relevant to the implementation of the Protocol.

3. The First Conference also decided, as stipulated in paragraph 42 of its final document (CCW/P.V/CONF/2007/1), that the work of the Meetings of Experts shall be considered by the Conferences of the High Contracting Parties to be held annually.

4. The Sixth Review Conference of the High Contracting Parties to the Convention, CCW/CONF.VI/11, encouraged the High Contracting Parties to Protocol V, to "continue with their efforts to encourage a higher rate of national reporting, including through consideration at the Meeting of Experts; to consider in-depth the clearance of explosive remnants of war and generic preventive measures; and to prioritize the work on cooperation and assistance and victim assistance".

5. The 2024 Meeting of the High Contracting Parties to the Convention, in its final report, decided that the Nineteenth Conference of the High Contracting Parties to Protocol V would take place on 10 November 2025 (CCW/MSP/2024/7, paragraph 27 (d)).

6. On 25 November 2024, the High Contracting Parties to Protocol V designated, through a written silence procedure, Ambassador Thomas Göbel of Germany, as President-designate of the Nineteenth Conference.

7. The Nineteenth Conference of Protocol V was prepared for by a Meeting of Experts, which took place on 8 September 2025 in Geneva, as decided by the 2024 Meeting of the High Contracting Parties to the Convention in its final report (CCW/MSP/2024/7, paragraph 27 (a)).

II. Participation in the Nineteenth Conference

8. The Nineteenth Conference of the High Contracting Parties to Protocol V on Explosive Remnants of War (ERW) was convened on 10 November 2025 at the Palais des Nations in Geneva.

9. The following High Contracting Parties to Protocol V participated in the work of the Conference: Albania, Argentina, Australia, Austria, Bangladesh, Belarus, Belgium, Brazil, Bulgaria, Burkina Faso, Cameroon, Canada, China, Côte d'Ivoire, Croatia, Cuba, Czech Republic, Denmark, Dominican Republic, Ecuador, Estonia, Finland, France, Georgia, Germany, Greece, Holy See, Hungary, India, Iraq, Ireland, Italy, Kuwait, Lao People's Democratic Republic, Latvia, Lithuania, Montenegro, Netherlands (Kingdom of the), Nicaragua, North Macedonia, Norway, Pakistan, Panama, Paraguay, Peru, Philippines, Poland, Portugal, Republic of Korea, Russian Federation, Saudi Arabia, Slovakia, Slovenia, South Africa, Spain, State of Palestine, Sweden, Switzerland, Tunisia, Ukraine, United Kingdom of Great Britain and Northern Ireland, and United States of America.

10. The following High Contracting Parties to the Convention participated in the work of the Conference as observers: Israel, Japan, Morocco, Serbia, Sri Lanka and Türkiye.

11. The following States not party to the Convention participated as observers: Azerbaijan and Thailand.

12. Representatives of the following organizations took part in the work of the Conference as observers: European Union, Geneva International Centre for Humanitarian Demining (GICHD), International Committee of the Red Cross (ICRC), and United Nations Mine Action Service (UNMAS).

13. Representatives of the following non-governmental organizations and other entities also took part in the work of the Conference as observers: Article 36 and DMUN Foundation.

III. Work of the Nineteenth Conference

14. The Nineteenth Conference of the High Contracting Parties to Protocol V on ERW was opened on 10 November 2025 by Mr. Obay Al-Taii of the Republic of Iraq, on behalf of Ambassador Abdul-Karim Hashim Mostafa of the Republic of Iraq, President of the Eighteenth Conference, who presided over the election of Ambassador Thomas Göbel of Germany.

15. The Conference held two plenary meetings. The High Contracting Parties were not able to adopt the agenda, as contained in CCW/P.V/CONF/2025/1, and were not able to confirm the rules of procedure, as contained in CCW/P.V/CONF/2013/10, as no consensus on this matter was reached.

16. The CCW Implementation Support Unit provided administrative support to and prepared documentation for the Conference.

17. The Conference had before it documents CCW/P.V/CONF/2025/1, CCW/P.V/CONF/2025/2, CCW/P.V/CONF/2025/3 and CCW/P.V/CONF/2025/4. The Conference did not consider the report of the 2025 Meeting of Experts of the High Contracting Parties to Protocol V contained in CCW/P.V/CONF/2025/2. The report, which has not been agreed upon and has no official status, reflects the discussions held on clearance of explosive remnants of war and technical assistance and on victim assistance. The documents of the Conference will be made available in all official languages on the CCW website (<https://meetings.unoda.org/node/74776/>), as well as through the United Nations Official Document System (ODS), at <http://documents.un.org>.

18. Pursuant to the decision of the First Conference to establish a database on Protocol V, in accordance with Article 10 (2) (b) of Protocol V, consisting of the national reports, annual or immediate updates of the national reports, and/or summary cover pages, if applicable, on matters pertaining to the implementation of Protocol V, as stipulated in paragraphs 24 to 28 of the final document of the First Conference, the Conference had before it national annual reports from the following High Contracting Parties: Albania, Argentina, Australia, Austria, Belarus, Belgium, Bosnia and Herzegovina, Brazil, Bulgaria, Burundi, Canada, Chile, China, Côte d'Ivoire, Croatia, Cuba, Czech Republic, Denmark, Ecuador, El Salvador, Estonia, Finland, France, Georgia, Germany, Greece, Holy See, Hungary, Iceland, India, Iraq, Ireland, Italy, Kuwait, Lao People's Democratic Republic, Latvia, Liechtenstein, Lithuania, Luxembourg, Mauritius, Moldova, Netherlands (Kingdom of the), New Zealand, Nicaragua, Norway, Pakistan, Peru, Poland, Portugal, Qatar, Republic of Korea, Russian Federation, Slovakia, Slovenia, Sweden, Switzerland, Ukraine, United Kingdom of Great Britain and Northern Ireland, United States of America, and Uruguay.

IV. Follow-up

19. The Conference decided that the 2026 Meeting of Experts will be for a duration of one day at a date to be decided by the 2025 Meeting of High Contracting Parties to the Convention, to be held on 12 November 2025.

20. The Conference decided that the Meeting of Experts should especially focus on the following issues, at the discretion of the President-designate of the Twentieth Conference:

- (a) The issue of the universalization of Protocol V under the overall responsibility of the President-designate of the Twentieth Conference;
- (b) Article 4 of the Protocol under the overall responsibility of the President-designate of the Twentieth Conference;
- (c) National reporting under the overall responsibility of the President-designate of the Twentieth Conference;
- (d) Victim assistance under the overall responsibility of the Coordinator on Victim Assistance;
- (e) Clearance of explosive remnants of war under the overall responsibility of the Coordinator on Clearance and Technical Assistance.

21. The Conference decided to nominate a representative of the Eastern European Group (EEG) as President-designate of the Twentieth Conference, and a representative of the Non-Aligned Movement (NAM) Group and a representative of the Western European and Others Group (WEOG) as Vice-Presidents-designates.

22. The Nineteenth Conference encouraged High Contracting Parties in a position to do so to provide technical assistance to the High Contracting Parties in need of such support.

23. The Conference considered and approved a provisional agenda of the Twentieth Conference, as contained in Annex I.

24. The Conference adopted the estimated costs of the 2026 Meeting of Experts and Twentieth Conference, contained in CCW/P.V/CONF/2025/3 and CCW/P.V/CONF/2025/4 respectively.

25. At its second plenary meeting, the Nineteenth Conference of the High Contracting Parties to Protocol V on Explosive Remnants of War adopted its final document as contained in CCW/P.V/CONF/2025/CRP.3, as orally amended, which will be issued as document CCW/P.V/CONF/2025/5.
